9	WHEREAS, in accordance with Section 21D(a)(3)(B)(v) of the Exchange Act, 15 U.S.C. § 78u-
10	4(a)(3)(B)(v), Ina seeks approval of his selection of Faruqi & Faruqi, LLP to serve as Lead Counsel and
11	Muckleroy Lunt, LLC to serve as Liaison Counsel for the putative class.
12	AND NOW THIS 15th day of November, 2018, the Court having considered the
13	motion of Ina for (1) Consolidation, (2) Appointment as Lead Plaintiff, and (3) Approval of Lead
14	Counsel and all supporting documents, it is hereby ORDERED as follows:
15	CONSOLIDATION
16	1. The motion of Ina to consolidated the above-captioned actions (the "Consolidated
17	Action") is GRANTED.
18	2. Pursuant to Fed. R. Civ. P. 42(a), the above-captioned actions are to be consolidated for
19	all purposes, including, without limitation, discovery, pretrial proceedings, and trial.

2	action in the Consolidated Action. When the document being filed pertains to all actions, the phrase
3	"All Actions" shall appear immediately after the phrase "This Document Relates To:" in the caption.
4	When a pleading applies only to some, but not all, of the actions, the document shall list, immediately
5	after the phrase "This Document Relates To:" the docket number for each individual action to which
6	the document applies, along with the last name of the first listed plaintiff in that action.
7	5. All related actions subsequently filed in, or transferred to, this District shall be
8	consolidated into the Consolidated Action.
9	LEAD PLAINTIFF
10	6. The motion of Ina to serve as Lead Plaintiff in the Action is GRANTED. Pursuant to
11	Section 21D of the Exchange Act, 15 U.S.C. §78u-4(a)(3)(B), Ina is appointed as Lead Plaintiff for the
12	putative class.
13	LEAD COUNSEL
14	7. The motion of Ina for approval of his counsel as Lead Counsel and Liaison Counsel is
15	GRANTED. Pursuant to Section 21D of the Exchange Act, 15 U.S.C. §78u-4(a)(3)(B)(v), Faruqi &
16	Faruqi, LLP is approved to serve the Lead Plaintiff and the putative class as Lead Counsel, and
17	Muckleroy Lunt, LLC is approved to serve the Lead Plaintiff and the putative class as Liaison Counsel.
